- 3. Then edit your original draft and incorporate a summary of findings from the project. Submit the final document through eLearning as instructed by the counseling faculty.
- 4. Create a visual display of the main points of your work.
- 5. Participate in the formal poster presentation typically scheduled spring semester of your final year.
