Core social work values include service, social justice, dignity and worth of the person, importance of human relationships, integrity and competence.

There are many motivations for pursuing a career in the helping professions and for specifically becoming a social worker. The UNI Social Work Admissions Committee reserves the right to deny an applicant's admission to the major based upon factors that negatively impact the potential to become a social worker and make positive contributions to the field.
